

# A hat-trick of awards for Ward Hadaway

ARD Hadaway, which has offices in Newcastle, Leeds and Manchester, walked off with three awards at the inaugural Northern Law Awards.

Ward Hadaway trainee solicitor James Fairman was named trainee of the year, the property team at the firm's Newcastle office was named property team of the year and Ward Hadaway managing partner Jamie Martin won the outstanding achievement award.

Covering legal practitioners across the North East and Cumbria, the Northern Law Awards showcases and celebrates outstanding achievement in the legal industry.
